WNCLB reserves the right to decline an application which is deemed, <u>for any reason</u>, not to be in the best interest of the City of Wilmington, Delaware and the Wilmington Neighborhood Conservancy Land Bank.

TERMS AND CONDITIONS

- If applicant has previous real estate experience in the City of Wilmington with a negative real estate history
 including, but not limited to, property tax delinquency including New Castle County, code violations, liens
 or foreclosures, the application will be denied unless applicant can demonstrate that the identified matter
 has been resolved to the full satisfaction of WNCLB.
- 2. The Urban Garden Lease application may be denied if the lot is part of a development project.
- 3. The lessee may ONLY utilize the vacant site as an urban garden as detailed in the lease agreement with raised garden beds.
- 4. No more than one lot will be transferred to an applicant unless approved otherwise by the Disposition and Governance Committees and the WNCLB Board of Directors.
- 5. This is a "lease agreement" program only and ownership of the vacant lot remains with the WNCLB. The lease is for a one-year term, and the WNCLB, at its discretion, may choose to extend the lease term. WNCLB is not responsible for water connections/use on the site.
- 6. The applicant must obtain the community members' approval at the designated civic association meeting in the district where the parcel is located. Should a civic association not exist for the district, the applicant must obtain the City of Wilmington Council Member's approval in the district where the parcel is located.
- 7. The program operates on a "first come first served basis". The first qualified applicant to submit a complete application will receive priority consideration.
- 8. The lessee must be able to maintain the property in accordance with all local and zoning codes. The lessee must also maintain <u>adequate insurance</u> for the site as detailed in the lease agreement.
- 9. Should the lessee not adhere to the terms and conditions of the Urban Garden Lease Agreement, WNCLB reserves the right to take possession of the property immediately.
- 10. The WNCLB reserves the right to change, modify or amend these procedures at any time.
