#### **Finance Committee Report**

- Becky Provided a Partial report as we are in a period of transition with Financials.
- Breakwater will be caught up on finances in a relatively short time.
- Becky Provided a snapshot of our current banking accounts and financial activity for the last three months. Land Bank Is operating in the positives.
- Receipt of 1.5 million dollars for revitalization and rehabilitation from the state of Delaware.
- About 2.3 million dollars of funds in the bank. Approximately a Million is restricted to the Hilltop initiative.
- State ARPA Funds (SLFRF) are restricted to the east side.
- Data is essentially ready for the 2022 Audit.

- General updates: 445 units of new construction completed, 219 in progress, 540 rehabs done since the Mayor took office.

## **Fundraising Report/ Community Outreach**

- B. Freel provided the fundraising report.
  - 1.5 million in ARPA funds awarded evenly between the Eastside and Hilltop projects after consultation with the Governor.
  - Awarded \$100,000 from Barclays.
  - Awarded \$100,000 from WSFS distributed evenly over 3 years.
  - Another Federal Earmark was passed, and Senator Coons put the Land Bank in for 3 million dollars. 6 million dollars we have in federal money.
  - Mayor proposed in his budget, 1 million dollars for the Wilmington Land Bank.
  - Bud continues to do walks around the area.
  - Recently walked with Senator Darius Brown and Kyle Gay.
  - Reps from SHPO and members of the "Out and About" Magazine staff toured the Hilltop.
